

The European University Viadrina is an internationally and interdisciplinarily oriented institution located in the twin city of Frankfurt (Oder)—Słubice, spanning both the Polish and German sides of the River Oder. It educates approximately 4,000 students from around the world in degree programs across law, economics, and cultural studies. ## W3 Professorship in Criminal Law, Criminal Procedure Law, and Related Fields,

to be filled as of **1 October 2026**. The professorship is intended to strengthen teaching and research at the Viadrina with a particular focus on criminal law, criminal procedure law, and at least one related area of criminal law (in particular media criminal law, economic criminal law, IT criminal law, medical criminal law, or fundamentals) and to contribute to the university's academic profile.

## Applicants are expected to demonstrate:

- an outstanding and comprehensive publication record in the fields covered by the professorship;
- the ability to contribute to compulsory criminal law teaching, specialized elective tracks, and exam preparation for the First State Examination ("Unirep");
- a commitment to developing and implementing innovative teaching methods;
- an interest in designing and acquiring externally funded research projects.

## Additional desirable qualifications include:

- the ability to teach the subjects of the professorship in English;
- willingness to actively contribute to interdisciplinary projects and degree programs;
- interest in collaborating with practitioners in criminal law and integrating them into teaching:
- readiness to engage in international cooperation, particularly with colleagues from Central and Eastern Europe and especially the Faculty of Law and Administration at Adam Mickiewicz University Poznań;
- demonstrated gender and diversity competence in both research and teaching.

The position is open to scholars who meet the requirements of § 43 of the Brandenburg Higher Education Act (BbgHG). The professorship is tenured.

The European University Viadrina Foundation is strongly committed to diversity and equal opportunity for all employees. It places particular emphasis on implementing gender equality and inclusion measures and expressly encourages qualified female scholars to apply.
